- Intentional shooting bird houses, fence posts, and metal target stands will result in revocation of club membership and range key to the Range Committee.

**Applicant will receive a range key only after:**

- Attending an orientation on posted rules for the rifle, pistol, and shotgun ranges with a Rifle Committee member.
- Release/Waiver of Liability form is signed & returned.
- Key fee is paid.
